On January 26, 2016, a Complaint for Revocation of License was filed with the Insurance Commissioner by Kelvin W. Zimmer, Director of Producer Licensing for the North Dakota Insurance Department, alleging Sandra Fowler, NPN 17325078 ("Respondent"), committed various violations of North Dakota insurance statutes.

The Complaint was mailed to Respondent at the address on file with the Department by the United States Postal Service via certified mail, return receipt requested, on January 27, 2016. The certified mail was returned to the Department on February 25, 2016, marked "Unclaimed." Proof of service of the Complaint is annexed to these Findings. Respondent failed to answer the Complaint within 20 days as required under N.D.C.C. § 28-32-21(1)(e). As such, on March 3, 2016, an Application for Default Order was made deeming the allegations made in the Complaint to be admitted pursuant to N.D.C.C. § 28-32-30.

Based on the allegations made in the Complaint and on the evidence presented in the Affidavits filed in support of the Complainant's Application for Default Order, the following Findings of Fact, Conclusions of Law, and Default Order are entered:

FINDINGS OF FACT

Respondent is presently, and has at all times pertinent to this action, been an insurance producer licensed in North Dakota.

The Complaint was mailed to Respondent at the address on file with the Department by the United States Postal Service via certified mail, return receipt requested, on January 26, 2016. The certified mail was returned to the Department on February 25, 2016, marked "Unclaimed." Respondent failed to provide a written response to the Complaint.

Ш

Respondent has not answered the Complaint within 20 days as required under N.D.C.C. § 28-32-21(1)(e).

IV

Respondent has been licensed as a nonresident insurance producer in North Dakota since September 10, 2014.

٧

According to information obtained by the Department, on or about July 9, 2015, Maine revoked Respondent's nonresident insurance producer license. The Maine administrative action should have been reported to the Department by August 9, 2015, and it was not. Respondent's failure to report the Maine administrative action within 30 days is in violation of N.D.C.C. §§ 26.1-26-15 and 26.1-26-45.1(1).

During a review of Respondent's North Dakota record, additional administrative actions were discovered that should have been reported to the Department within 30 days and they were not. The additional administrative actions were as follows:

4/2/15	California – License Denied
4/23/15	Virginia – License Revoked
7/13/15	Indiana – License Suspended-Indefinite
8/4/15	Ohio – License Surrendered
9/22/15	Georgia - License Suspended-Indefinite

Respondent's failure to report each of the additional administrative actions to the Department within 30 days is in violation of N.D.C.C. §§ 26.1-26-15 and 26.1-26-45.1(1).

VII

On or about October 30, 2015, a letter was sent by certified mail, return receipt requested, to Respondent at her mailing address on file with the Department requesting information relating to the administrative actions. Delivery of the certified mail was accepted on November 2, 2015. Respondent failed to respond to the Department's request for information. Respondent's failure to respond to a written request for information by the Department within 20 days is a violation of N.D.C.C. §§ 26.1-26-15 and 26.1-26-42(14).

VIII

Respondent's actions constitute violations of N.D.C.C. §§ 26.1-26-15, 26.1-26-42(14), and 26.1-26-45.1(1) and are grounds for revocation of Respondent's insurance agent license.

CONCLUSIONS OF LAW

- 1. Respondent was properly served with the Complaint in accordance with the North Dakota Rules of Civil Procedure.
- 2. Because of her failure to answer the Complaint within 20 days of its proper service, Respondent is in default under N.D.C.C. § 28-32-30.
- 3. Because Respondent is in default, the allegations in the Complaint are deemed admitted pursuant to N.D.C.C. § 28-32-30.
- 4. Respondent's violations of N.D.C.C. §§ 26.1-26-15, 26.1-26-42(14), and 26.1-26-45.1(1) are grounds for revocation of her insurance producer license.
- 5. Under N.D.C.C. § 26.1-26-42, the Commissioner of Insurance has authority to revoke Respondent's producer license for the violations cited above.

DEFAULT ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, IT IS

ORDERED that the North Dakota insurance producer license of Sandra Fowler, NPN

17325078, be **REVOKED** effective after the time for filing a motion to vacate a Default

Order pursuant to N.D.C.C. § 28-32-30 expires.
